Eraclene PF 92 is a homopolymer high density polyethylene resin (HDPE), with antioxidants, suitable for pipe application.

It is characterized by high rigidity, high impact strength and low swelling. Eraclene PF 92 has an intermediate molecular weight distribution which perfectly balances overall performances with ease of processing.

# **Main Application**

Eraclene PF 92 is recommended for the production of structured wall pipes when high rigidity is required. It can be used for the production of sheets and profiles.

# **Processing notes**

Eraclene PF 92 can be processed in the latest high speed extrusion lines with excellent results.

Typical moulding conditions:

Temperature setting, barrel zone 1 (°C) 170 - 180
Temperature setting, barrel zone 2-4 (°C) 185 - 195
Temperature setting, head and die (°C) 185 - 195
Operation temperature (°C) 210 - 220

#### Storage and Handling

Eraclene PF 92 is supplied in pellet form. This material may readily be conveyed and bulk fed through equipment designed for conventional pelletised polyethylene resin, provided the equipment is designed to prevent accumulation of the fines and dust particles that are contained in all polyethylene resins. These fines and dust particles can, under certain conditions, pose an explosion hazard. We recommend that the conveying system used be equipped with filters of adequate size, operated and maintained in such a manner to ensure that no leaks develop and earthed adequately. We further recommend that good housekeeping should be practised throughout your facility.

The product should be stored in dry conditions at temperatures below 50 °C and protected from sunlight. Improper storage can initiate degradation which results in odour generation, colour changes and can have negative effects on the physical properties of the product.

Before using this product it is recommended to read and understand the relevant Safety Data Sheet.
