Greenflex FL 45 is an ethylene vinyl acetate copolymer (EVA) for extrusion/co-extrusion blown and cast film. Films produced with Greenflex FL 45 show a low fish eyes content, good elasticity, good optical properties, good sealability at low temperatures.

Main Application

Greenflex FL 45 is recommended for the production of co-extrusion film, lamination film, stretch film, stretch hood, barrier film for food packaging, agricultural film and for all those applications where the typical purity of film grades is required.

Processing notes

Greenflex FL 45 can be processed by conventional blown film extrusion equipments. Operation temperature from 150 $^{\circ}$ C to 170 $^{\circ}$ C is recommended. Depending on extrusion conditions, the suggested film thickness is from 25 to 80 μ m.

Storage and Handling

Greenflex FL 45 is supplied in pellet form. This material may readily be conveyed and bulk fed through equipment designed for conventional pelletised polyethylene resin, provided the equipment is designed to prevent accumulation of the fines and dust particles that are contained in all polyethylene resins. These fines and dust particles can, under certain conditions, pose an explosion hazard. We recommend that the conveying system used be equipped with filters of adequate size, operated and maintained in such a manner to ensure that no leaks develop and earthed adequately. We further recommend that good housekeeping should be practised throughout your facility.

The product should be stored in dry conditions at temperatures below 50 °C and protected from sunlight. Improper storage can initiate degradation which results in odour generation, colour changes and can have negative effects on the physical properties of the product.
